## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

CLARTAN - PATRIMOINE is a precautionary savings product that seeks to increase the capital invested over a period of more than two years, with the intention of preserving it.

For the part of the sub-fund invested in bonds, the investment policy is chosen depending on the maturity of the portfolio and the quality of the issuers.

The portion of the portfolio not invested in bonds is said to be bottom-up, which means that when taking investment decisions, financial analysis of the companies takes precedence over the perception of the financial markets and the economic and political climate, which supports these decisions.

The sub-fund invests:

- from 50% to 100% of its net assets in debt securities and money market instruments (of which at least 50% in bonds rated at least BBB- by Standard & Poor's or equivalent denominated in euros).

The sensitivity of the bond portfolio will be between 0 and 10. Debt securities may be sovereign bonds, corporate bonds or indexed bonds without maturity restrictions, equity equivalent securities or bonds such as convertible bonds, bonds with warrants, Negotiable Debt Securities and more specifically indexed debt securities. The sub-fund will not invest in contingent convertible bonds ("CoCos").

- up to 35% in shares of listed companies with no sector or capitalisation restrictions, of which a maximum of 20% in listed shares of non-OECD countries (including Chinese companies and in particular Chinese A shares listed on the markets of the People's Republic of China via the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect), priority dividend shares, investment certificates and equity securities.

The sub-fund may invest up to 10% of net assets in units of UCIs (including a maximum of 5% in money market funds).

The sub-fund may buy or sell options and forward financial derivative instruments: to hedge all or part of the portfolio and or achieve a performance

objective. Exposure will be limited to 100% of assets.

Any investor who would like a more detailed description of the investment strategy and the assets used is invited to refer to the prospectus.

**Benchmark:** The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended investor

This product is intended for investors seeking income and capital growth over the medium- to long-term (at least 2 years). The investor may incur losses up to the amount invested. This product is suitable for investors with basic and in-depth knowledge and experience of the product and global bond markets.

#### Other information

**Depositary:** Banque de Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

**Be aware of currency risk.** You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## What happens if CLARTAN ASSOCIÉS is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

## How long should I hold it and can I take money out early?

### Recommended holding period: 2 years

You should be prepared to stay invested for 2 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
