## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Objectives

The sub-fund CLARTAN ETHOS ESG EUROPE SMALL & MID CAP aims, over a period of more than five years, to achieve a performance that is simultaneously positive in absolute value and greater than that of the main European indices (small and mid-caps) denominated in EUR, by applying Ethos' eight SRI principles, which have an advisory role for the sub-fund in this area.

ETHOS defines the investment universe among companies which manage their environmental, social and governance issues with conviction, which tend to have a positive impact on the environment and on society as a whole, on the basis of an ESG analysis, and an assessment of their strategy in the face of climate change as well as an assessment of the positive contribution of their products and services to solving current environmental and social challenges. The sub-fund's management committee applies an investment discipline based on qualitative criteria (sustainability of profitability) as well as on own valuation criteria (determining the valuation discount required to invest). For this reason, the sub-fund will be invested as follows:

- minimum of 75% in listed companies having their registered office in a Member State of the EEA.
- maximum of 25% in listed companies having their registered office in non-member states of the EEA that do belong to the Council of Europe.
- exclusively in shares of listed companies with a capitalisation of less than 20 billion euro at the time the company entered the sub-fund's portfolio.
- a maximum of 8% in cash or in money market units.

Investment in shares is performed without any sectoral or monetary restrictions. The sub-fund refrains from using derivative financial instruments, with the exception of foreign exchange contracts which are allowed to hedge short-term exposure in currencies when buying or selling securities in a currency other than the reference currency of the sub-fund. The sub-fund applies Ethos' "eight Socially Responsible Investment principles" in terms of exclusion, controversy,

ESG rating, exercise of voting rights and engagement in shareholder dialogue. For further details, please refer to the prospectus.

**Benchmark:** No relevant benchmark index, however, the Morningstar Developed Europe Mid Cap Target Market Exposure net return index, denominated in EUR, may be used as an index for information purposes.

#### Intended investor

This product is for investors seeking income and capital growth in the medium- to long-term (at least 5 years). The investor may incur losses up to the amount invested.

#### Other information

**Depositary:** Banque de Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

## What happens if CLARTAN SICAV is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
